- The roof leaked during the March 2<sup>nd</sup> storm. DPW came to look at the damage and fixed a light at the same time.
- Hirshberg will try to get prizes for Summer Reading from the Land of Make Believe and Wild West City. Bahnuk suggested Crayola and Munson said to try The DaVinci Science Center.

Committees The Capital Improvement Committee met and started making a list of possible

Projects. Fisher will investigate the 2023 monies from the Town. DeFazio (with her husband's help) will look into adding some cameras.

Old Business The First Amendment gentleman called about making a documentary. He did

New Business The cost of toner and paper is on the rise, so the director would like to adjust the
